Subject:- Categorization of the Deemed to be University under UGC [Categorization of Universities (only) for Grant of Graded Autonomy] Regulations, 2018.

Sir,

As you are aware, UGC is mandated to determine, promote and maintain the standards of higher education in the country. UGC is constantly striving to create an enabling environment whereby higher educational institutions in the country can become institution of global excellence. UGC is also aware that global excellence can be achieved by extending autonomy to better performing institutions for promoting and institutionalizing excellence in higher education.

In order to grant autonomy to the better performing institutions, UGC has notified UGC [Categorization of Universities (only) for Grant of Graded Autonomy] Regulations, 2018 on 12th February, 2018 in the Gazette of India.

The proposal received from **Gandhi Institute of Technology and Management (GITAM)** under the above UGC Regulations has been examined, processed and considered by the Commission in its 530th meeting held on 20.03.2018. **The Commission has decided to grade the Gandhi Institute of Technology and Management (GITAM) as Category-I Deemed to be University as per the provisions of the above UGC Regulations.** The Deemed to be University shall now be eligible for all the benefits as stipulated under Clause 4 (Dimensions of Autonomy for Category-I Universities) of the above mentioned UGC Regulations. However, with respect to Clause 4.3 of the Regulations (pertaining to opening of constituent units/off-campus centres), the Commission is in a process of finalizing certain modalities related to its implementation. The same will be communicated separately.

The Deemed to be University shall inform the UGC about the benefits being implemented from the new academic session. In light of this, the Deemed to be University should acknowledge in writing that it shall strictly comply with all the regulations as mentioned in the provisions (Clause 4) of the University Grants Commission (Categorization of Universities (only) for Grant of Graded Autonomy) Regulations, 2018.

It is further informed that the Deemed to be University shall intimate the Commission about its changed status as per Clause 6 of the said regulations.

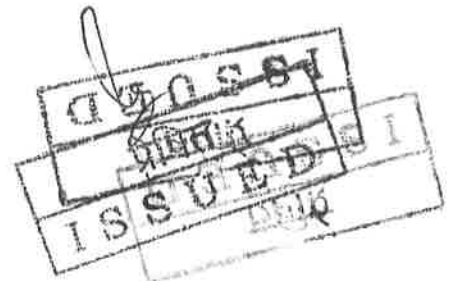

This has reference to the letter No. GDY/CAO/R/AICTE/222/2020 dated 19.06.2020 received from the Registrar, Gandhi Institute of Technology and Management (GITAM), (Deemed to be University), Gandhi Nagar Campus, Rushikonda, Visakhapatnam (Andhra Pradesh) regarding status of the graded autonomy of Gandhi Institute of Technology and Management (GITAM), Off-campus, Bengaluru. In this regard, I am to inform you that the Government of India, Ministry of Human Resource Development, on the advice of UGC, declared Gandhi Institute of Technology and Management (GITAM), Gandhi Nagar Campus, Rushikonda, Visakhapatnam – 530045, Andhra Pradesh as deemed to be university vide notification no. F.9-37/2006-U.3 (A) dated 13-8-2007. The Government of India accorded approval to the following off-campus of GITAM:-

Subject: Granting of 12(B) status to deemed to be universities to declare them fit to receive central assistance.

Sir,


The University Grants Commission in its 472nd meeting held on 27th September, 2010 while considering the issue for granting the 12(B) status to deemed to be universities to declare them fit to receive central assistance, inter-alia decided as under:-

- (i) ***Deemed to be Universities, which are receiving salary and maintenance grants from M/HRD, Government of India (GOI), may be awarded 12(B) status if they fulfill the eligibility criteria. They would also be eligible to receive grants from UGC.***
- (ii) ***Deemed to be Universities, which are receiving salary and maintenance grants from a government source other than M/HRD, GOI, may be awarded 12(B) status if they fulfill the eligibility criteria. They may be considered for financial assistance from UGC subject to availability of funds.***
- (iii) ***Self Financing Deemed to be Universities, which are partially funded by the State or Central Government in the form of salary and maintenance grants, may be awarded 12(B) status if they fulfill the eligibility criteria. They may be considered for financial assistance from UGC subject to availability of funds.***
- (iv) ***Self Financing Deemed to be Universities, which are not receiving salary or maintenance grants from the government but are receiving some grant for any other purpose from the State or Central Government, may be awarded 12(B) status if they fulfill the eligibility criteria. They may be considered for financial assistance from UGC subject to availability of funds.***

- (v) *Self Financing Deemed to be Universities, which are not receiving grants from any purpose from the State or Central Government, may be awarded 12(B) status if they fulfill the eligibility criteria. However, they would not be eligible to receive any grants from UGC.*
- (vi) *All Deemed to be Universities, public or private, which are presently receiving grants from UGC shall continue to do so as per present terms and conditions.*

A copy of the UGC (Fitness of Certain Universities for Grants) Rules, 1974 along with the format is enclosed for your information and necessary action, if any.
